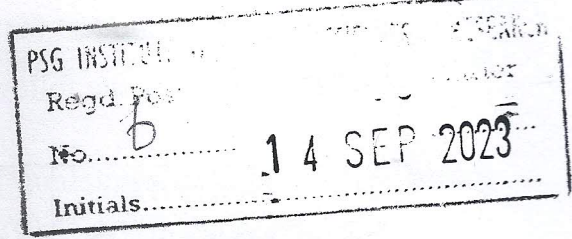

**ORDER:**

The Tamil Nadu Nurses and Midwives Council resolves to grant **Continuance of Provisional Recognition** to **PSG College of Nursing, Coimbatore** to conduct the following programmes for the academic year **2022-2023** subject to the following conditions:

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2022-2023 and admission must be made only once a year.
3. Every year list of candidates admitted during the year together with their age and qualification to be uploaded in the **Council's Institution Management System (I.M.S.)** for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
4. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.
5. **The institution should submit the copy Affiliation Order from the University for the academic year 2022-2023.**



6. Failure to maintain the prescribed requirements will result in de-recognition.
7. The Council is entitled for surprise inspection without any prior notice. If the institution is found unsuitable, the recognition will stand cancelled and thereupon the Council shall not be responsible for the students admitted by the institution
8. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, State Government /Indian Nursing Council, New Delhi from time to time.
9. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
10. Annual Programme fee of B.Sc.,(N) & M.Sc.,(N) must be paid by 30<sup>th</sup> June every year through online mode in Council website under the link "INSTITUTION MANAGEMENT SYSTEM".
11. **Council Prescribed Uniform should be adoned by the students and it should be strictly adhered.**
12. All the correspondence should be done by the Principal only.

In the reference 6<sup>th</sup> cited, the Government in G.O(Ms.)No.168, Health and Family Welfare (PME) Department dated 11.06.2010 has granted permission to P.S.Govindasamy Naidu and Sons Charities, Coimbatore District to increase the annual intake of seats from 50 to 100 in B.Sc Nursing Course conducted by "P.S.G College of Nursing" at Peelamedu, Coimbatore from the academic year 2010-2011 and the University has granted permission for increase of intake from 50 to 100 seats in B.Sc(N) Degree Course from the academic year 2010-2011 vide in the reference 7<sup>th</sup> cited

7. In the reference 8<sup>th</sup> cited, Grant of Continuance of Provisional Affiliation was issued for the academic year 2020-21 to the said institution to conduct B.Sc(N) with an annual intake of 100 seats and M.Sc(N) with an annual intake of 30 seats (MSN.-6, Paed.-6, OBG-6, CHN-6 & Psy.-6) degree courses.

8. In the reference 9<sup>th</sup> cited, the Tamil Nadu Nurses & Midwives Council, Chennai has published the list of colleges of Nursing for B.Sc(N) and M.Sc(N) degree courses recognised for the academic year 2021-2022 and 2022-2023, wherein, "P.S.G College of Nursing" at Peelamedu, Coimbatore has been recognised to conduct B.Sc (N) programme with an annual intake of 100 seats and 30 seats (MSN.-6, Paed.-6, OBG-6, CHN-6 & Psy.-6).

9. Based on the resolution no. 51, passed at the 287<sup>th</sup> Governing Council meeting held on 22.12.2021, Virtual Inspection has been conducted on 16.03.23 to assess and report on the infrastructural, teaching and other facilities available at "P.S.G College of Nursing" at Peelamedu, Coimbatore for considering the grant of Continuance of Provisional Affiliation for conducting B.Sc(N) and M.Sc(N) degree courses for the academic year 2021-2022.

10. In the resolution no. 42, passed at the 292<sup>nd</sup> Governing Council meeting held on 03.08.2022, it was resolved to grant orders of Continuance of Provisional Affiliation /Conditional Continuance of Provisional Affiliation for the academic year 2022-2023 based on data submitted in the Affiliation portal and the virtual inspection conducted for the academic year 2021-2022.

11. The Seat Matrix has been informed to the Selection committee for the academic year 2021-2022 and 2022-2023 in respect of B.Sc(N) and M.Sc(N) degree courses.

12. The said institution has remitted the requisite fee for the academic years 2021-2022 and 2022-2023.


