- 3. In the reference 3rd cited, the University has granted the Permission for increase of intake from 40 to 60 seats in B.Pharm. degree course from the academic year 2006-2007.
- 4. In the reference 4th cited, the University has granted Continuance of Provisional Affiliation for 60 seats and Permission for increase of intake from 60 to 100 seats in B.Pharm. degree course from the academic year 2020-2021.
- 5. In the reference 5th cited, the University has granted the Provisional Affiliation order to P.S.G. College of Pharmacy, Coimbatore for conducting the M.Pharm. Degree Course in following branches:
